The Board Chair called the meeting to order with recognition that we are on Treaty 6 Territory, a traditional meeting grounds, gathering place, and travelling route to the Cree, Saulteaux, Blackfoot, Métis, Dene and Nakota Sioux. We acknowledge all the many First Nations, Métis, and Inuit whose footsteps have marked these lands for centuries.

The Board Chair advised that the fire alarm system at the Centre for Education is a Two Stage alarm system. Stage One is a single repeating alarm tone indicating a warning only and that evacuation is not required. Stage Two is a triple repeating alarm tone indicating that evacuation is required.

The Board Chair advised those attending the meeting in person that the floor area is restricted to the Board of Trustees, Superintendent, Director of Board and Superintendent Relations and Recording staff, with an area reserved for media. She advised that she would signify to any other staff or registered speakers to come down to the floor at the designated time on the agenda. The Board Chair thanked everyone for their cooperation.

Vice-Chair Dunn advised that at the September 24, 2019, Board meeting a motion was referred to the Caucus Committee. She reported that the motion has been referred back to the October 8, 2019, Board meeting and that she would like to amend the agenda to bring this motion forward under agenda Item K: Notices of Motion.

D. **Communications from the Board Chair**

The Board Chair thanked everyone who has reached out and shared their thoughts on the use of seclusion rooms. She said these conversations aren’t always easy but they are important. She advised that Administration has put in a regulation with strict guidelines and that the District is part of the conversation on provincial guidelines due out at the end of October 2019.

The Board Chair remarked that provincial legislature reconvened as of today and that the Board looks forward to the tabling of the provincial budget on October 24th and hopes the Government of Alberta sees the importance of providing adequate and predictable funding to school boards across the province.

The Board Chair advised that every October, the District is proud to recognize two key staff groups who do so much to support our students and schools. She shared that October 2nd was National Custodial Staff Appreciation Day, when the District honoured more than 600 custodians and CUPE Local 474. She said these professionals keep our buildings safe, clean and comfortable. She also shared that October 5th was World Teachers' Day. The Board Chair acknowledged that teachers dedicate every day to helping students succeed and develop a lifelong love for learning. To recognize both of these staff groups, the District shared messages of thanks and videos highlighting their work on the District website and social media channels. The Board Chair thanked these staff members for their dedication.

The Board Chair shared that the theme of this year's READ IN Week, which runs from October 7th to 11th, is *Celebrate with Stories* and that READ IN Week is celebrating 30 years of instilling the love of reading in all Edmontonians. She said that READ IN Week is a remarkable success story, thanks to the support of the District's many partners, our community and generous sponsors. The Board Chair advised that this annual week-long celebration has expanded partner involvement, renewed interest and focus on the joy of reading within the entire Edmonton Community. On behalf of the Board of Trustees, she invited all Edmontonians to participate in READ IN week 2019.

E. Communications from the Superintendent of Schools

The Superintendent reported that on September 27, 2019, one of the District's new school namesakes, Aleda Patterson, passed away. He advised that she was a former teacher in the District, and was instrumental in establishing the Personal Development Centre, now known as The Support Network. She was also the founder of the Edmonton ABC Head Start program. Since 1984, the ABC Head Start Society has grown from a single location serving 10 children and families to a comprehensive early learning, family support and community program, supporting over 430 families at different locations throughout Edmonton. He said although she will be missed in her many professional and personal circles, comfort can be found in the fact that her life was well lived. Her legacy will live on at Aleda Patterson School in the Afton neighbourhood.

The Superintendent advised that the District is continuing to grow and now has 105,000 students. This is an increase of 3,065 more students than last year which is the equivalent of over 100 new classrooms of students. He shared that this is the ninth year of consecutive growth.

The Superintendent reported that on September 24, 2019, the Government of Alberta released the Provincial Achievement Test and Diploma Exam results for the 2018-2019 school year and that he was proud to share that District students did very well. Highlights include strong student performance across the majority of grades and subjects and a greater percentage of students completing high school within five years. The Superintendent congratulated students on their accomplishments and thanked District staff who work tirelessly to prepare students to achieve this success.

The Superintendent reminded everyone that Thanksgiving is close and that the District has a lot to be thankful for – dedicated staff, keen and curious students, and supportive parents and community partners. He shared that he hopes everyone will have an opportunity to spend time with loved ones and wished those traveling to be with friends and family outside of Edmonton safe travels.

ISSUE

The Student Senate is presenting their work plan for the 2019-2020 school year to the Board of Trustees.

BACKGROUND

The Student Senate serves as a youth engagement model to promote active student participation in youth governance within education and to provide the Board of Trustees with a meaningful way to access student voice. To help focus the direction and energy of the Student Senate, they establish a yearly work plan informed by the voice of their peers. The Student Senate reports on their efforts to meet their work plan goals at three public Board meetings throughout the year.

In the spring of 2019, Edmonton Public high schools selected up to two students per high school to provide representation on a 2019-2020 Student Senate. The 2019-2020 Student Senators met with the 2018-2019 Student Senate on June 11, 2019, to ensure transition between the two groups of students. The 2019-2020 Student Senate met on September 11 and October 9, 2019, to complete the following tasks:

- elect three Student Trustees: Josh Karathra, Johanna Lau, Tristin Odnokon
- elect four Student Senate Executives: Chair Cindy Liu, Vice Chair Rajan Maghera, and Secretaries Hamza Khan and Raj Singh
- identify the topic for a youth engagement event

CURRENT SITUATION

For the previous three years, Student Senators have gathered student input on the question, “What are the most important issues related to education and school for students today?” The material was then themed and Student Senators selected three topics and based their year’s work around projects related to the three topics.

While this process produced good learning and outcomes, it required a lot of time before topics were narrowed and project work could begin. Therefore, this year, in an effort to allow for more time for actual project work, Student Senators were provided with an overview of the data gathered through

student engagement by the previous three years of Student Senators and given the task of choosing one topic to serve as the theme for a spring symposium.

The data showed that four topics repeatedly were of most interest to students: life skills, mental health, diversity and cohesion, and environment. This year's Students Senators were given these four topics, along with the 16 sub-topics the themed data revealed. Through table conversations and a "dot-mocracy" exercise, they selected their theme.

In the 2019-2020 school year, the Student Senate will also be providing youth perspective to Board and Division initiatives. Throughout the year, the Board and Division administration will be able to access youth voice through the Student Senate about a broad range of topics relevant to high school students.

KEY POINTS

- Student Senators elected three Student Trustees and four executive.
- The Student Senators chose a theme for a youth symposium to be held in spring 2020, based on three years of student answers to the question, "What are the most important issues related to education and school for students today?"
- Student Senators will establish committees to further refine the theme and plan the symposium.
- The Student Senate will provide youth perspective to the Board of Trustees and Division administration about a range of topics throughout the year.
- Student Trustees will report their progress towards their work plan goals at the February 25, 2020 public Board meeting.
