The Board Chair called the meeting to order with recognition that we are on Treaty 6 Territory, a traditional meeting grounds, gathering place, and travelling route to the Cree, Saulteaux, Blackfoot, Métis, Dene and Nakota Sioux. We acknowledge all the many First Nations, Métis and Inuit whose footsteps have marked these lands for centuries.

## D. Approval of Agenda

#### E. Communications from the Board Chair

The Board Chair stated that over the past month, following the election, Trustees have been busy with orientation, meetings with provincial associations, and other duties.

The Board Chair thanked all Central Decision Units that hosted Results Review last week and all school communities that have participated and will participate in Results Review later this week.

The Board Chair reported that all Trustees attended both the Alberta School Boards Association (ASBA) Fall General Meeting (FGM) and the Public School Boards Association of Alberta (PSBAA) Annual General Meeting (AGM) last week. The ASBA FGM kicked off with an awards night, recognizing Edwin Parr Award winners like Breanna Tran Lee from Weinlos School and various organizations and community partners. In addition to some important professional development, the general meetings were an excellent opportunity for both new and returning trustees to come together and discuss both issues in their local school divisions and provincial advocacy items. Chair Sumar offered thanks to the outgoing ASBA President (Marilyn Dennis) and PSBAA President (Dennis MacNeil), and congratulated the new Presidents, Shali Baziuk (ASBA) and Lorraine Stewart (PSBAA), expressing the commitment to work closely with the new executives to continue to advocate for public education.

The Board Chair shared that last week also marked the Transgender Day of Remembrance. Chair Sumar said, "To the transgender community and Division students in particular. No one can erase your existence, your joy, or the community that cares about you. There is a future where you are safe, celebrated, and free. Don't doubt who you are or that you are enough. Trans lives belong everywhere." He also expressed pride in the previous Board's work on the Sexual Orientation and Gender Identity and Expression (SOGIE) policy.

The Board Chair also acknowledged that this month is Hindu Heritage Month. It's an opportunity to remember, celebrate and educate future generations about Hindu Canadians and the important role they have played and continue to play in the community.

The Board Chair reported that both Delton and Spruce Avenue schools are advancing to construction. Both of these projects had previously been on the 3-Year Capital Plan for the better part of two decades. Chair Sumar expressed gratitude that the need to replace these schools has been recognized and that these and other infrastructure projects are moving more quickly through the different stages of funding.

The Board Chair confirmed that Trustee Nichol will be the TEBA Representative for EPSB.

The Board Chair advised that he and some Trustees attended the New Teacher Induction Ceremony for the ATA Local 37. The Chair noted the inspiring nature of the event, where new inductees took their oaths and committed to continuous learning and dedication. The Chair expressed gratitude to the new teachers for choosing the Division, acknowledging teaching as a noble profession and a calling.

## F. Communications from the Superintendent of Schools

The Superintendent thanked everyone in attendance today, including the Superintendent's Community of Practice in Education (SCOPE) principals, Shauna Paul from Thelma Chalifoux School and Brad Mamchur from Michael Phair School, and those watching online.



The Superintendent shared that Trustee Results Reviews started last week with the Division's Central Reviews, and will continue this week with Division School Trustee Results Reviews. These are great opportunities to share with staff and the community the amazing things happening around the Division.

The Superintendent thanked principals, Central Decision Unit administrators, and the Board of Trustees for their preparation and participation in the upcoming Results Review conversations. He noted that these sessions provide an important opportunity to review the previous school year's work and understand future planning, which is valuable for all participants, especially those new to the process.

The Superintendent congratulated Jillian Marino, principal at Vimy Ridge Academy, for being named one of the Top 10 school principals in Canada by Education Insider. Jillian is a seasoned educator who focuses on advancing academic achievement, cultivating resilience in youth and empowering both students and staff on their shared learning journey. Jillian believes that small incremental changes can make a significant difference and encourages students at Vimy Ridge Academy to grow in both academics and athletics, living by the school's mantra, "We uplift those we serve by uplifting those who serve them."

The Superintendent congratulated Shaminder Parmar for recently being recognized as a Top 40 under 40 for 2025. These awards highlight individuals who are shaping Edmonton's future through innovation, leadership and community impact. Shaminder is a senior planner with the Division's Infrastructure team and is chair of the Joint-use Land Management Steering Committee, which brings together all of Edmonton's public planning bodies to collaboratively tackle infrastructure challenges. Shaninder is also a passionate animal rights advocate and is president of the Laurel Community League.
