Key Highlights

- 81 per cent of children entering Grade 1 met developmental milestones.*
- On PAT exams, 76.1 per cent of students in Grades 6 and 9 met the acceptable standard and 25.6 per cent met the standard of excellence.**
- On diploma exams, 83.9 per cent of students in Grades 10-12 met the acceptable standard, and 28.2 per cent met the standard of excellence. Diploma results continue to improve compared to five years ago.**
- High school completion rates continue to improve compared to five years ago.**
- The number of students eligible for a Rutherford Scholarship and transitioning to a post-secondary program (including apprenticeship) has been steadily increasing.**
- 88.6 per cent of teachers, parents and students agree students are safe at school, are treated fairly, and are learning the importance of caring for and respecting others.**
- 83.2 per cent of teachers, parents and students are satisfied that students model active citizenship.**

First Nations, Métis, and Inuit students in Alberta are successful

Key Highlights

- On PAT exams, 50.3 per cent of self-identified First Nations, Métis, and Inuit students in Grades 6 and 9 met the acceptable standard and 6.8 per cent met the standard of excellence.**
- On diploma exams, 80.8 per cent of self-identified First Nations, Métis, and Inuit students in Grades 10-12 met the acceptable standard, and 14.8 per cent met the standard of excellence. Diploma results continue to improve compared to five years ago.**
- High school completion rates continue to improve compared to five years ago.**
- The number of students eligible for a Rutherford Scholarship has been steadily increasing.**
- Transition rates to a post-secondary programs have continued to improve compared to five years ago.**

Alberta has excellent teachers, school leaders, and school authority leaders

Key Highlights

- 87.8 per cent of teachers reported that the professional learning they received contributed significantly to their ongoing professional growth.**
- 82.5 per cent felt they had the knowledge and skills to support students needing specialized services.***
- 85.3 per cent felt they had the knowledge and skills to support English Language Learners.***
- 75.5 per cent felt they had the knowledge and skills to support First Nations, Métis, and Inuit students.***


